*Document must be notarized with signature and stamp (unless letter of waiver is on file). Exporters must ensure that: Name and address are included. Consignee's name and address are included. Itemized merchandise matches that listed on invoice (if invoice is provided). Country of origin is listed and matches that on invoice (if invoice is provided). If the country of origin is other than

Canada, the certificate must indicate this. Place and date are provided. Company official has signed the document.







